Call for Contributor of Papers

Dhaka University Journal of Business Studies is a half-yearly journal of the Faculty of Business Studies published in June and December. The Journal contains research based papers on business, industry, trade and development related issues.

Contributors are requested to submit articles/papers for publication.

The following may kindly be treated as broad guidelines for submission of the article/paper:

- The articles/papers should be research based and should demonstrate the author's own thought and judgement.
- The manuscript must be typed (times roman, 11 pt.) on one side of the paper in double space and normally should not exceed 20 pages.
- All notes except those included in tables and diagrams should be numbered consecutively.
- An abstract of 150 words or less (times roman, 8 pt.) should be given along with the article/paper.
- Name(s) and designation of the author(s) with the title of the article/paper should be provided on a separate sheet.

Bibliographical references should be made in a defined structure.

In the case of article, the citation should be as follows:

Author's last name, first name and middle initial, years of publication, "Title of the article"; name of the journal (to be underlined/italicised), volume number (month) : page number.

For example,

I, Ahmed A. S. and C. Takeda 1995, Stock Market Valuation of Gains Losses on Commercial Banks' Investment Securities - An Empirical Analysis, Journal of Accounting and Economics, Vol. 20 (September) : 207-225

In the case of text book, the citation should be as follows:

Author's last name, first name and middle initial, years of publication, "Title of the Book (to be underlined/italicised)", name of the publisher.

For example,

Nichols, D. 1989, The Handbook of Investors Relations, Homewood, IL: Dow Jones-Irwin.

For citation of published papers/books in the text, it should be, for example, as follows:

- a. Nichols (1989)
- b. Forsythe and Lundholm (1992)
- c. (e.g. see Camerer and Weigelt 1988; Kagel and Roth 1995)
- d. (FASB 1986:9)
- e. (Collins and Salatka 1993:122)

Typed manuscripts for publication should be submitted to the Editorial Office, Business Studies Bhaban, University of Dhaka.
